Dear Sir,

We have requested earnestly to Commissioner, Land & Land Reforms Department, Government of West Bengal to issue instruction to the Land Reforms Officials in charge of District and Block Levels so that the names of Primary Teachers' Training Institutes and DIETs be mentioned in Record of rights which are at present generally noted with the words ' শিক্ষা দপ্তর, পশ্চিমবঙ্গ সরকার ' or such other abbreviations.

The reason behind such request was circular issued from National Council of Teacher Education wherein it has been made mandatory that the land be recorded in the name of institute to get the Institute recognized by NCTE. (A copy of the Circular No. F 48-3(1)/2008 NCTE (N&S) C/2017 dated 13.3.2009 is enclosed).

The Land Reforms Commissioner in his no. 2141(18)/IS/33/09 dated 25<sup>th</sup> March, 2009 has requested all District Land & Land Reforms Officers of the State to render all possible help in this regard considering the plight of nearly 32,000 no. of P.T.T.I. Trainees whose Training Institutes have been declared un-recognized and the certificate awarded to them as void.



Dear Sir,

Enclosed please find the list of Government, Government Sponsored and Aided P.T.T.I.s of West Bengal, DIETs (District Institute of Education & Training) are those institutes set-up under Central Scheme of Teacher Education – one in each district (except Darjeeling). In most of the cases Government/Government Sponsored P.T.T.I.s are converted to DIETs, in few cases DIETs have been set-up afresh.

We require the general instruction/circular to be issued from your part requesting your D.L.L.R.O.s to please issue a 'Land Certificate' on the basis of "as is where is" as the documents like inter-departmental transfer of land (from other Departments to Education Department) in most cases are not readily traceable.

A copy of such circular may please be forwarded to the undersigned so that we can send it to our Principals of these P.T.T.I.s/DIETs to get in touch with D.L.L.R.O./B.L.R.O. to obtain the 'Land Certificate'. The matter of recognition of these 60 (sixty) odd P.T.T.I.s/DIETs are pending with National Council of Teacher Education, Eastern Regional Committee for want of their certificate.

A prompt action from your end is earnestly requested so that we may get the recognition and start P.T.T.I. training from July, 2009 onwards.
